 RECONVENING OF 2010 ANNUAL MEETING MINUTES

CALL TO ORDER: Reconvening of the 2010 Annual Meeting called to order at 7:02 PM by Clerk/Treasurer Becky Herman.

Purpose of the Reconvening to approve 2011 Budget and Levy.

Leftover prizes (school supplies) were donated to Hastings Family Service. Hastings Family Service sent letter of thanks. 2010 approved expenditure of up to \$1000 has an unused balance of \$466.79. An additional disbursement of \$119.26 (for newsletter mailing) from the general fund will be posted against the Town Celebration fund (total expenditures for the 2010 celebration, \$652.47.). For the purpose of keeping the account open at First National Bank, \$20 shall remain in the account and \$446.79 shall be returned to the Town's general fund. Town of Denmark shall also be added to account. Resident consensus to have a 2011 Town Celebration. **Motion Moore/2nd Keller to authorize expenditures not to exceed \$1000.00 for a 2011 Town Celebration. All In Favor. Motion Carried.**

Motion Keller/2nd Kramer to approve the Proposed 2011 budget (T. \$810,834) and the Proposed 2011 Tax Levy per fund, (T. \$441,213) as presented. All In Favor. Motion Carried.

Motion Moore/2nd Kramer to adjourn the 2010 Annual Meeting. All In Favor. Motion Carried.
